**All Caravan Park Refunds**

*- Off Peak and Shoulder periods*

22 If a customer cancels 2 weeks prior to their arrival date in off-peak times, they are entitled to a refund of their deposit less a 20% administration fee.

23 If a customer cancels within the 2-week period prior to their arrival in off-peak times, the customer is not entitled to a refund.

24 However, at the Manager's discretion, if the accommodation/site is filled for all of the original days booked, we may refund the deposit less 20% administration fee.

25 *- Peak*

26 If a customer cancels 4 weeks prior to their arrival date in peak times, they are entitled to a refund of their deposit.

27 If a customer cancels within the 4 week period prior to their arrival date in peak times, the customer is not entitled to a refund.

28 However, at the Manager's discretion, if the accommodation/site is filled for all of the original days booked, we may refund the deposit less 20% administration fee.

29 Refund payment by Direct Deposit or Cheque will be made via Council's accounts payable system.

30 EFTPOS and Cash Refund will be made onsite.

31 All refunds are made at the discretion of the Management
