## Other Information

Registration of cats and dogs is a requirement from the age of 12 weeks, registration for all cats and dogs is in accordance with *the Animal Management (Cats and Dogs) Act 2008* and *Local Law No. 2 (Animal Management) 2011*. Microchipping is mandatory for all cats and dogs at 12 weeks of age and or upon transfer of ownership, microchipping is not a retrospective requirement. Desexing if recommended for all domestic cats and dogs (pets) at the appropriate age and Council encourages desexing through reduced fees, please contact your vet for further information.

1. Proof of desexing is to be provided at the time of registration in the form of a Veterinarian's certificate or letter.
2. Certificate must be provided at time of registration.
3. Working Dogs are required to be registered at a reduced fee, however they must meet the criteria under the Animal Management (Cats and Dogs) Act 2008. The Working Dog Self-Assessment Checklist must be attached to this application.
4. Regulated dogs include Restricted, Declared Dangerous or Declared Menacing which incur additional registration fees. If the animal is a Restricted Dog, an Application for Restricted Dog Permit must be submitted with this application.
5. Evidence of membership with the Canine Control Council or Qld Feline Association must be provided at time of registration.
