Current visitors to Causeway Lake are drawn to its laid back natural setting adjacent to national park and the southern most reach of the Great Barrier Reef.



## BRING BACK THE DEPTH

Siltation has reduced the lake's depth to approximately **less than 0.5m deep** across 80% of its area.

The loss of depth and fish habitat has led to a decline in fish stocks. Ongoing siltation may cause the open water body to eventually transform into saline marsh.

The overall effect of this on the community has been to reduce the lake's suitability for recreational activities for which it was best known.

In response to this, Livingstone Shire Council have commissioned preliminary investigations into dredging design solutions and their feasibility based on previous reports that examined the siltation process.


This master plan assumes an increased lake depth made possible through dredging.







If Council dredged the lake and enhanced the lake shorelines **how likely would you be to visit the precinct then?**





# SITE OPPORTUNITIES & CONSTRAINTS

## CONSTRAINTS

### RECREATION

- Little to entice or facilitate swimming in the lake
- Limited shoreline-water engagement opportunities and limited existing activities
- Generally ad hoc provision of picnic and other recreation facilities, many without shade. Generally not taking full advantage of the site's natural appeal
- Some conflict between recreational uses (swimming / fishing; motorised / non-motorised watercraft)
- No dedicated fish cleaning area despite popular use by fishers
- Public perceptions of safety risk by potential crocodiles and stone fish

## OPPORTUNITIES

- Strong community interest in lake restoration and enhancement of shoreline recreation opportunities
- History of being a popular recreational destination supported by community desire to restore historic lake uses
- Increase patronage of existing business and increase revenue generation by supporting new business opportunities
- Existing Council facilities (picnic, amenities, shower)
- Existing accommodation can support more visitation and events
- Sheltered still-water location supports recreation and watercraft training
- Potential adventure use of undeveloped vegetated lots around western shores and their existing trails

### ENVIRONMENT

- Increasingly shallow water
- Maintaining existing 'natural' character distinct from Yeppoon and Emu Park's developed public spaces
- Protecting important vegetation and habitats from disturbance caused by increased recreational use

- Dredging to restore depth
- Can leverage existing mature vegetation to provide increased shade and amenity
- Add value to lake destination by improving the adjacent coastal connection to the adjacent National Park and other State lands
- Dredging can support improved fish stocks

### ACCESS & PARKING

- Perceived safety risk of narrow width of existing path along Causeway, conflicting users (pedestrians & fishers), and close proximity to traffic severely constrains pedestrian movements between North and South Shores
- Limited and very informal parking
- 'Unofficial' boat ramp on North Shore maintained by Council



- Lake has excellent visibility from Scenic Highway
- Increased car and boat parking to support increased recreation and events resulting from lake improvements
- Planned Sailability boat ramp upgrade; existing Main Roads owned boat ramp
- Proximity to bus stops

### SERVICES & OWNERSHIP

- No sewer to South Shore amenities
- All the currently utilised lake edge is state owned under Council control or sub-leased
- Alterations to Causeway structure may be difficult, costly and protracted

- Negotiating with state / privately owned lots for public access
- Convert unnecessary road reserves to public open space
- Existing sewerage amenities on North Shore

# EXECUTIVE SUMMARY

Causeway Lake is a place of natural beauty at the mouths of Shoal and Mulambin Creeks, where a semi-artificial lake was created with the construction of a causeway in 1939. The causeway acts as a barrier to retain creek waters whilst also allowing some tidal exchange.

Initially the causeway enabled recreational activities such as swimming, sailing, boating, fishing and water skiing but the reduction in water depth caused by ongoing siltation has decreased the lake's suitability for these pastimes.

The Causeway Lake Master Plan proposes lakeside improvements to accompany selective dredging that will restore areas of water depth and the lake's reputation as a recreation destination.

A community survey heard passionate voices advocating for infrastructure and activities to increase lake access and participation while preserving its quiet scenic character.

Following are improvements and changes that could be realised, in response to lake dredging, to optimise the service of the lake precinct as a premier local recreation attraction.

## CAUSEWAY LINK

The 1.5km Causeway Link path will be a walking destination that connects the North and South Shores, crossing the lake and giving locals and visitors the chance to enjoy the water's edge. It will provide commuters a safe lake crossing alternative to the Scenic Highway and be accessed from the road and car park areas via a network of smaller compliant paths suitable for users of all abilities. This will transform Causeway Lake into an inclusive destination suitable for the whole community and a greater range of visitors.



## NORTH & SOUTH SHORES

The Causeway Link will have mixed construction depending on the lake edge it abuts. Where the existing lake edge is deteriorating, a concrete path and retaining wall will assist with stabilisation and prevent the edge from dispersing into the lake. Where the lake edge contains sensitive vegetation, a raised timber deck will retain and protect vegetation while allowing important ecological processes such as evapotranspiration to continue.

Causeway Lake will be a day trip destination with two distinct but complementary offerings: passive recreation and gathering on the North Shore and active adventures on the South Shore. These characters optimise existing facilities.

Common to both shores will be the lake's scenic natural setting, with existing vegetation retained as much as possible. New shade trees will further enhance the lake's natural character, comfort for visitors and habitat for wildlife.

### NORTH SHORE – VILLAGE GREEN

The North Shore will be a Village Green for visitors drawn by a new lakeside restaurant and picnic facilities, an upgraded playground and shady open space for markets and informal recreation. A new Ocean Pool will offer bathers a safe and sheltered swimming alternative to coastal beaches. The Ocean Pool will cater for all swimming abilities with both dedicated deep water and wading areas, accessed via a compliant ramp or wide terrace steps where carers can sit comfortably at close range.

The North Shore will be home to a new launch for non-motorised watercraft activities typical of day trip destinations such as stand-up paddle boating, kayaking and pedal boats. This facility will support the existing Boat Hire Shed and be collocated with a new car park which will also service visitors seeking the mangrove and beach experiences at the western end of North Shore.



The Sunset Shelter is positioned over the water at the west of the North Shore for unobstructed sunset views. It connects with a new boardwalk skirting the mangrove's edge to another shelter suitable for bird watching. The boardwalk will provide educational opportunities and sensitively step through an area of Least Concern Wildlife Habitat (Matter of State Environmental Significance) to connect the Mulambin and Causeway Lake communities.

### SOUTH SHORE – EVENT HUB

The South Shore will continue to be the home of boating and sailing with dedicated boat ramps for each. New facilities will include picnic shelters, a pontoon with shelter and all-abilities watercraft launch, and car and boat trailer parking. The existing open space will be expanded and shaded with new tree planting to better facilitate rigging activities and larger community events. Power and authorised vehicular access to the open space will enable pop-ups or food trucks to cater for large crowds.

Compliant paths will provide direct access between these facilities, sailing sheds, and a new amenity block that will include general and disability cubicles as well as Changing Places cubicles to accommodate people with disabilities together with their carers. The new amenity block will assist in resolving existing conflicts between users of varying abilities associated with the Sailability Club and the Keppel Bay Sailing Club when their activities occur simultaneously.

An adventure trailhead located at the western end of the South Shore will connect to a bush trail network for visitors wanting a land-based environmental experience. The combination of land and water-based activities with open space and amenities will attract triathlon and adventure racing events which often have charity causes appealing to more than just sportspeople.



## FISHING



Causeway Lake will continue to be a popular destination for fishing, which was the most popular lake activity recorded in the community survey. The Causeway Link will increase access to the lake's edge, and fishing platforms where it crosses the lake's mouth will provide closer access to the most rewarding fishing spot, where large predatory fish wait to feed on the incoming tide's baitfish.

The popularity of fishing will likely increase as the fish numbers increase, buoyed by increasing lake depth and potentially a fish stocking program. This demand will be supported by a fish cleaning shelter and measuring station with car parking, collocated with fishing platforms. These will assist in managing fish waste which could be unpleasant if disposed of within the lake and may cause safety concerns by attracting predatory animals.

## BOATING AND SAILING



As boating and sailing are two of the most popular activities at Causeway Lake, it is anticipated that a Lake Use Plan would be developed by Council to manage conflicts between motor and non-motorised watercraft.

Motorboat access to the lake will be via the existing Transport and Main Roads owned boat ramp accessed off Resada Esplanade. Boating visitors will be supported by increased boat trailer parking adjacent to Coolwaters Caravan Park, and by upgrades to the boat ramp's access road which will likely be required for dredging activities. The informal boat ramp on the North Shore is proposed to be closed to establish a safe passive activity zone there instead.

Primary sailing users of the lake are associated with the Sailability Club and Keppel Bay Sailing Club who both believe their activities and numbers could significantly increase with enhanced facilities. To support this, a new a pontoon with shelter and an all-abilities watercraft launch is proposed adjacent to the existing sailing ramp which has already secured funding for an upgrade. The existing Sailability Club shed will be joined by new storage for the Keppel Bay Sailing Club, replacing existing temporary storage containers. Both clubs will have authorised access to the pontoon and sailing ramp via a maintenance track secured by lock rails.

## ADVENTURING



Causeway Lake is much loved for its scenic beauty. Optimising access into its creeks and mangroves and connecting with the adjacent National Park will expand the lake's experiences, appealing to a greater range of visitors as a day trip destination.

Causeway Lake will provide access to a range of distinct environments and wildlife habitats:

- Bush interior accessed via the South Shore's Adventure Trailhead
- Mangroves accessed via the North Shore's Mangrove Boardwalk
- Small beach experiences accessed at the west of the North Shore or on the South Shore via an Eco trail shortcutting between the ramp for motorboats the Causeway Link
- Small islands and beaches along Shoal and Mulambin Creeks discoverable by non-motorised watercraft launched from either North or South Shores
- Pinnacle Point section of Capricorn Coast National Park accessed via the North Shore beneath the Causeway or from the existing car park east of the Scenic Highway. Although no National Park walks exist in this section, the lake's inlet here is accessible at low tide providing access to a dramatic rocky coast and Mulambin Beach. More adventurous walkers can meander along the beach to reach National Park trails at the Bluff Point section less than 2km north, and potentially another 9km north to Yeppoon Lagoon by combining trails, beaches and local paths.

## PARKING



For Causeway Lake to be a successful day trip destination with the least disturbance for residents, the existing limited car parking will need to be increased. Car parks have been located away from the lake's edge to maximise public access to recreation areas. Landscape buffers to car parks are proposed where they directly abut residents or businesses. Parking is proposed in key locations:

### NORTH SHORE

- Ware Avenue – parallel parking adjacent the Causeway Caravan Park
- Causeway Esplanade
  - Parallel parking adjacent the Causeway Caravan Park. Existing vegetation is proposed to be retained and augmented with a 5m landscape buffer to screen car parking from the caravan park
  - Parallel parking adjacent 29 Causeway Esplanade
  - A new car park requiring purchase of a currently vacant lot adjacent to the Fish and Chip Shop
  - Formalised car parking adjacent to the proposed Fish Cleaning Shelter off Causeway Esplanade where a clearing currently facilitates informal parking
- Pinnacle Street – a new car park north of the Boat Hire Shed in an existing clearing

It is proposed to realign the section of road fronting 27-29 Causeway Esplanade and the intersection with Pinnacle Street to increase the open space area beside the lake, making it a safer and more pleasant place by distancing traffic. Large tree planting along Causeway Esplanade will create a boulevard to enhance pedestrian experience and provide amenity for adjacent residents.

### SOUTH SHORE

- Formalise existing car and boat trailer parking at the ramp for motorboats
- New car park off Resada Esplanade to cater for both cars and boat trailers. Existing vegetation is proposed to be retained and augmented with a 5m landscape buffer to screen car parking from the caravan park

While the existing Resada Esplanade appears to directly connect the Scenic Highway to the ramp for motorboats, its gazetted alignment passes west of the Sailability Club's shed. The master plan proposes that the gazetted road be adjusted to match the existing use alignment.

## SCENIC HIGHWAY

The existing car park beside the National Park is proposed to be expanded into existing cleared areas. Upgraded pedestrian access across the Scenic Highway at its intersection with the car park entry and Causeway Esplanade would increase safety for visitors and draw more lake visitors to engage with the National Park's coastal offering.

Should lake users or event crowds become significantly large, additional parking may be viable east of Scenic Highway off the intersection with Resada Esplanade.

Bus stops on the Scenic Highway at both the North and South Shores could alleviate car parking and cater for a greater range of visitors if pedestrian access could be upgraded between them and the Causeway Link.

## REVENUE



The Causeway Lake Master Plan envisages a variety of opportunities which complement the lake's recreational uses and have the potential to generate revenue for both the private sector and Council. Revenue generating opportunities may include:

- Lakeside restaurant lease
- Watercraft hire lease/permit
- Pop-up kiosks, food trucks and markets permit
- Event use (sporting competitions, charity events) permit
- House boats accommodation leases
- Boat tour permit

# ACTION LIST

## RECREATION

**OCEAN POOL** Resurrect the lake's swimming history by introducing a safe all-tide swimming area that has both designated lap swimming and wading areas. Give Causeway Lake an instagrammable identity by incorporating a unique recreation 'island' visible from the Scenic Highway.

**LAKESIDE RESTAURANT** Encourage more visitors by introducing more food offerings including a lakeside restaurant and areas for food trucks during high visitation.

**UPGRADED PLAYGROUND & PICNIC AREAS** Attract families to the lake by improving the play offering and providing facilities to accommodate family and birthday gatherings.

**OPEN SPACE** Improve the overall quality, appeal and usability of open space through additional plantings, addressing underutilised areas, adding shaded picnic and family event facilities, lighting, improved shoreline interaction and other enhancements.

**FISHING PLATFORMS** Enhance one of the lake's most popular activities with dedicated fishing platforms and a cleaning and measuring station.

**WATERCRAFT & SAILING FACILITIES** Enable increased sailing and watercraft use by adding shade structures and pontoon. Provide a launch access to the lake for small craft such as canoes, paddle boards and kayaks. Replacing existing shipping containers with a storage shed.

## ENVIRONMENT

**RETAIN VEGETATION** Protect wildlife habitat and the lake's much loved natural character by retaining mature trees and vegetation. Replace vegetation where possible.

**MANGROVE BOARDWALK & BUSH TRAILS** Encourage environmental stewardship by leading visitors through natural areas via educational mangrove boardwalks and bush trails.

## ACCESS

**THE CAUSEWAY LINK** Give visitors access to a broader range of the lake's experiences by joining the north and south shores via a new shared path.

**COASTAL CONNECTION** Enhance the lake's day trip destination status by connecting it via safe accessible paths to the Capricorn Coast National Park and beaches within the Great Barrier Reef World Heritage Area.

**IMPROVED PATH NETWORK** Increase visitor accessibility by making paths suitable for pedestrians and cyclists of all abilities. Path connections between streets, activity areas, facilities and the shoreline.

**SHARED ZONE** Transform the Causeway Esplanade into a speed-limited zone to increase visitor safety and foster a more pleasant pedestrian experience.

**ROAD REALIGNMENT** Realign the west section of Causeway Esplanade to increase open space against the lakeside, suitable for markets and informal recreation.

## SUPPORT INFRASTRUCTURE

**CAR PARKS** Cater for increasing visitation and resolve existing conflict by providing appropriate car and boat trailer parking.
