The *Order-in-Council* dated the sixth day of April 1899 and published in the *Government Gazette* of 15 April 1899 created the Division of Fitzroy by excising Division One from the Gogango Division, and reconstituting the latter into two Subdivisions, governed by a Board of six members, three each for each Subdivision. This resulted in the former Subdivision Two becoming Subdivision One, and the former Subdivision Three becoming Subdivision Two.

In April 1899, former Board Chairman and now MLA and Minister for Railways and Works in the State Government, Mr John Murray was credited with "*bringing about the separation of the Division.*"
