

# MANAGEMENT OF WASTE AND RECYCLING SERVICES POLICY (COMMUNITY POLICY)

The Management of Waste and Recycling Services Policy ('this Policy) applies to the provision of waste management services in Council's local government area.

This Policy identifies principles to inform and guide the development of Procedures relating to Council's waste management practices.

## 5. Policy Statement

Council is committed to providing general waste collection that is cost effective, meets the needs of the community and incorporates strategic and environmentally responsible waste management practices.

### **5.1 Procedure Development Framework**

To exercise its functions as a service provider and to facilitate the good rule and governance of its local government area, Council will develop waste management procedures that:

- a) support Local Law No. 8 (Waste Management) 2018;
- b) facilitate Council achieving cost effective and environmentally responsible waste management practices;
- c) provide the principles for the operation of Council's waste and recycling collection;
- d) ensure the provision of waste management services that meet ratepayers and Council's expectations;
- e) reflect its desire to treat ratepayers equitably in the allocation of funding for waste management services against competing interests and within budget constraints;
- f) are instructive, provide a consistent approach and clear direction in the exercising of its functions and obligations; and
- g) provide criteria that guide responsive and informed decision making which meets community expectations.

# 6. Changes to this Policy

This Policy is to remain in force until any of the following occur:

- 1. The related information is amended/replaced; or
- 2. Other circumstances as determined from time to time by Council.

## 7. Repeals/Amendments

This Policy repeals Livingstone Shire Council Policies titled:

- a) 'Waste and Recycling Collection Policy (v5)';
- b) 'Waste and Recycling Community Service Obligation Policy (v3)'; and
- c) 'Waste Voucher Policy (v1)'.
