

NAMING INFRASTRUCTURE ASSETS PROCEDURE

1. Scope

The Naming Infrastructure Assets Procedure (this 'Procedure') applies to the naming or renaming of existing infrastructure assets and the naming of assets contributed to Council through development works as defined by the *Planning Act 2016*.

This Procedure does not apply to a place prescribed under the Place Names Act 1994.

2. Purpose

Naming of infrastructure assets provides an opportunity to honour individuals and groups for contributions and achievements that deserve recognition.

This Procedure enables Council to apply commemorative naming to infrastructure assets in a consistent manner to ensure that:

- a) Public consultation is undertaken where necessary and nominations received from the public are assessed against pre-determined criteria to ensure transparency;
- b) New names do not conflict with names presently in use;
- c) New names are not racist, derogatory, demeaning or likely to give offence;
- d) Council's road network has an easily recognisable system of names that assist both pedestrians and motorists and provides a safe traffic environment; and
- e) Council's parks and reserves can be easily identified.

4. Definitions

To assist in interpretation, the following definitions shall apply:

Council	Livingstone Shire Council.	
Infrastructure Asset	An item or facility under the control of Council including roads and road related infrastructure, parks, reserves, playgrounds, sporting fields and monuments.	
Road	As defined in the Local Government Act 2009.

5. Procedure

5.1 Instigation

The naming or renaming of an infrastructure asset may be instigated in the following circumstances:

- a) By resolution of Council;
- b) When the Manager Engineering Services:
 - authorises a request from a member of the community be processed under this procedure;
 - Determines it is in the public interest to undertake the process outlined in this procedure; or
 - is required to assign a name under Item 5.5.

5.2 Process

When an infrastructure asset is to be named or renamed, the following steps are to be followed:

- a) Council's website and social media channels will call for naming proposals giving a three week deadline for submissions;
- b) The Manager Engineering Services may seek specific input from certain community groups, property owners/residents or other representative bodies to ensure that sufficient community consultation takes place;
- c) Nominations are to be assessed against Appendix 1 by the Manager Engineering Services plus two other employees of Council. The results of the assessment are to be reported to Council with a recommendation; and
- d) Council, at its discretion, may adopt, alter or reject any recommendation presented.

5.3 Assessment against Criteria

All nominations must be assessed against Appendix 1. In addition, the following are to be considered:

- a) The relevant heads of consideration identified in Item 4 of AS/NZS 4819:2011: Rural and urban addressing (regardless of the type of infrastructure asset being named);
- b) To assist both service providers and the travelling public to read, understand and recognise names quickly and efficiently, names should be reasonably easy to read, spell and pronounce;
- c) Where it is intended that a road be given the same name as a place or feature with an approved or accepted geographical name, particular care should be taken to ensure the correct spelling is adopted unless there are exceptional circumstances requiring a different spelling:
- d) When names have been changed or corrupted by long established local usage, it is not usually advisable to attempt to restore the original form. The spelling which is sanctioned by general usage should be adopted, eg Berry/Barry, Schwarz/Schwartz; and
- e) Whenever practicable, it is highly desirable that names are confined to word lengths which can be accommodated on road name signboards without exceeding the following lengths:
 - No more than 1200mm for single post end mounted;
 - No more than 1800mm for single post centre mounted; and

• Signs at intersections on roads of 80km/h and greater shall be 200mm deep with 150mm lettering on the sign facing the high speed traffic.

5.4 Road Type Selection Principles

To determine a road type, Council will comply with Item 4.3 of AS/NZS 4819:2011: Rural and urban addressing.

5.5 Development (Planning Act 2016)

1) Theme Name Areas

- a) The developer is to submit theme name areas along with a list of names that demonstrate the theme proposal.
- b) However, through roads leading from one theme area to another should have a generic name.
- c) Established theme names will be continued where possible.

2) New Infrastructure Assets

- a) The developer is to submit one name plus two alternatives.
- b) Usually, the developer's nominated name will be approved, provided there is no conflict with names presently in use.

3) Assessment and Approval of Names

- a) Item 5.2 does not apply to naming associated with development.
- b) While it is not necessary to follow the scoring matrix in Appendix 1, approved names should comply with the criteria.
- c) The Manager Engineering Services is authorised to assess and approve names under Item 5.5.

5.6 Service Provider Notification

When an infrastructure asset is named, the Manager Engineering Services is to notify the following where relevant:

- a) Australia Post:
- b) Australian Electoral Commission;
- c) Department of Resources (Land & Spatial Information);
- d) Queensland Ambulance Service;
- e) Queensland Fire and Emergency Services;
- f) Queensland Police Service:
- g) Ergon Energy;
- h) Telstra; and
- i) Livingstone Shire Council
 - · Revenue; and
 - Assets and GIS.

6. Changes to this Procedure

This Procedure is to remain in force until otherwise amended/replaced by the Director Infrastructure Services.

PROPOSED NAME:

Submissions that have any of the following characteristics are to be detailed in the report to Council and allocated a zero score:

- Are offensive, racist, derogatory, demeaning, likely to give offence or is out of place with surrounding names;
- Could be construed as advertising commercial or industrial enterprise;
- Names that have already been used;
- Where an individual has nominated themselves.
