SUMMARY

This Mayoral minute focuses on the clearing of vegetation for the purposes of bona fide bushfire management, and is consistent with the proposed amendments to the Livingstone Planning Scheme 2018 which will be presented to Council's Ordinary Meeting on the 3 December 2019

COUNCIL RESOLUTION

THAT Council resolve to facilitate the clearing of vegetation for the purposes of bona fide bush fire mitigation by not pursuing development applications for compliance action for clearing of vegetation on land where that clearing is defined as exempt clearing work under the *Vegetation Management Act 1997*.

This applies to land either mapped or not mapped as State and/or Locally Significant Vegetation for the purpose of establishing or maintaining necessary firebreaks to protect:

- 1) dwelling houses (maximum of twenty (20) metres or 1.5 times the height of the tallest adjacent tree, whichever is the greater); and/or
- 2) ancillary outbuildings, infrastructure (including existing fences), and roads and tracks, to a maximum width of ten (10) metres.


